The **BREEDER** guarantees the above described dog to be healthy at the time of sale. The breeder does not assume any liability for any injuries made to the puppy after delivery, due to the negligence of the buyer.

The **BUYER** agrees to have this puppy examined by a veterinarian within 72 hours of delivery and a photocopy of the Health Certificate sent to the breeder. If the puppy is found to be in poor health within the 72 hour time frame, then the breeder will refund the buyers money. If the buyer chooses not to have the puppy examined within 72 hours, this contract will become **NULL AND VOID** for any refund or replacement puppy.

The **BREEDER** provides a 25 month hip guarantee. Should the puppy be diagnosed with hip dysplasia, the breeder will replace the puppy under the following conditions:

- 1) The **BUYER** must provide a copy of documentation from the **ORTHOPEDIC FOUNDATION FOR ANIMALS (OFFA)** located in Columbia, Missouri, specifying that the puppy had hip dysplasia. This is the only documentation that will be deemed acceptable by the **BREEDER** for the purpose of supplying a replacement puppy.
- 2) Once the breeder has received a copy of the documentation from the **ORTHOPEDIC FOUNDATION FOR ANIMALS (OFFA)** and found acceptable, the **BUYER** must return (at the **BUYER'S** expense), the puppy and its' documents to the breeder.
- 3) The **BUYER** agrees that all vet costs for x-rays, etc., and costs involving submission of the hip x-rays to **(OFFA)** for evaluation, shall be the sole responsibility of the buyer.

The **BREEDER** provides a one year genetic health guarantee. Should the puppy expire prior to its' first birthday **DUE TO A GENETIC DEFECT**, the breeder will replace the puppy under the following conditions:

- 1) The **BUYER** agrees that should the puppy expire for unknown reasons and the buyer requests another puppy, then a necropsy should be performed on the puppy and a written statement is to be provided to the breeder as to the exact cause of death. If the puppy expired due to a **GENETIC DEFECT**, a replacement will be provided as soon as possible. **NO REFUNDS** will be made after 72 hours of ownership.
- 2) If the puppy is found to have a genetic defect during its' first year of life, a replacement puppy will be provided upon receipt of a written statement from a veterinarian as to the exact type of genetic defect, and upon return of said puppy and its' documents.
- 3) The **BUYER** agrees that all vet costs incurred on said puppy are the sole responsibility of the buyer.
- 4) The **BUYER** agrees that all shipping costs to return a defective puppy and to acquirer a replacement puppy, will be the sole responsibility of the buyer.

The **BUYER** agrees to maintain the puppy's health in good condition and provide yearly examinations, vaccinations and any other customary procedures necessary to good health.

The **BREEDER** has done everything possible to produce healthy, sound puppies and by raising the puppies in the best way possible in regards to diet, exercise, socialization and veterinary care. All necessary vaccinations for the puppy's age have been given, and a record of this vaccination and worming history is supplied to the buyer at the time of sale.

The **BREEDER** can offer no other guarantees once the care of the puppy is no longer under their control. The **BUYER** hereby agrees that if at anytime, the buyer cannot take proper care of the puppy, the buyer will contact the breeder and the breeder will have first choice to either:

- 1) Take the puppy back, or
- 2) Assist the buyer in finding a suitable home for the puppy.

The **BREEDER** neither makes nor implies any warranties or guarantees, express or implied, other than those written in this agreement. This document constitutes the entire agreement between **BREEDER** and **BUYER** with respect to this sale. The buyer's signature below indicates that he/she/ has read, understands, and agrees to all the conditions of the **SALES AGREEMENT**, and that this contract is under the jurisdiction

of the State of Illinois, in the County of DuPage. It is agreed the place of venue shall be DuPage County, Illinois.
